#### PREQUALIFICATION ELIGIBILITY CRITERIA

1. The Architectural firms / Consortia in which all partners are registered with the Council of Architecture in India or similar Organizations in other countries,

2. The Architect firms/consortia meeting the following minimum qualification criteria over the past three financial years ending March 2014 can apply with documentary evidence to the satisfaction of the evaluation committee for prequalification.

- (a) Architect firms / Consortia should have provided comprehensive architectural service for at least one single completed or on going building project of plinth area not less than 1,00,000 sqft in the last three years.
- (b) Architect firms / Consortia should have provided comprehensive architectural service for at least one completed or on going multistoried building having height not less than 40 metre in the last three years.
- (c) Architectural firms/Consortia should have done at least one completed or on going building project for a value of not less than Rs20.00 crores. (copy of work order and /completion certification for completed project, for ongoing project work order with certificate from the client stating the present stages of work to be furnished).
- (d) Architectural firm / Consortia should have had an average Annual Income as Architect fee of more than Rs 5.00 crores.(Copy of Income Tax Statement of profit and loss account statement to be furnished).
